The Nigerian Institute of Internal Affairs (NIIA) organized on January he Nigerian Institute of International 4, 2011, a one-day brainstorming session on the 16th Ordinary Session of the African Union Summit held between January 24 and 31, 2011. Against the background of the fact that the theme of the Summit, which is 'Towards Greater Unity and Integration through Shared Values', was suggested by Nigeria in the 2010 Addis Ababa 14th Ordinary Session of the AU, the NIIA brainstorming session was designed to generate ideas, advice and assist Nigeria in preparing its position at the AU Summit.

The Brainstorming Session was well attended. Participants were drawn from far and near, including some former Directors-General of the NIIA, some serving and retired Nigerian Ambassadors, Academics, the civil society, the private sector and the media, among others.

Discussions focused on the three main issues that would dominate the Agenda of the 16<sup>th</sup> Ordinary Session of the AU Summit, and these include Shared Values in African Union Unity and Integration, the Crisis in Côte d'Ivoire, and the Sudanese Question. A total of three leading presentations were made on each of these three issues across three sessions. They were all well discussed and debated on the floor of the Brainstorming Session.

#### **Observations**

After an exhaustive discussion and appraisal of the issues, the participants came up with the following observations:

#### On Shared Values

That:

1. Shared values are associated with positive beliefs and can be used for continental transformation and development.

#### **Editorial**

#### The New Roadmap

iianews is not simply news about the NIIA and its activities, but more about international affairs, in general, and international life, in particular. It is about the translation of policy into social life. In other words, it is another way of performing the functions of the NIIA in a relaxed mood and social setting.

As noted by Sir Abubakar Tafawa Balewa, Nigeria's Prime Minister and first Foreign Minister, "if Nigeria is to acquit herself honourably and to take her rightful place in resurgent Africa, she requires to be fully informed on the world of today, which is one of the paramount functions of the Institute".

This statement was made in 1961. It simply means that, if the NIIA provides the necessary information on global developments, Nigeria would be guided in acquitting "herself honourably" and taking her rightful place in resurgent Africa". In other words, the NIIA was conceived and designed to be an instrument for sustaining Nigeria's grandeur in global politics. Rightful place is about self-assertion and influence. It is about greatness and power. The NIIA is not simply meant to provide analytical data but also specifically required to play the role of a catalyst in the quest for a greater Nigeria.

Ir Adetokubo Ademola noted on 15th June, 1967 that "the NIIA hopes to work simultaneously on three levels; as a Nigerian Institute in Lagos, an African Institute in Nigeria and a world Institute in Africa, providing a meeting ground for people of all nations and a rich soil for a crossfertilization of their minds". Put differently, the NIIA is requested to simultaneously examine issues at the Nigerian domestic level, African continental level and the global level, as well as, examining how one

level impacts on the other. The NIIA is an intellectual world of its own and without the NIIA, the world of intellectualism is incomplete.

Consequently, as a foreign policy think tank, I Can confidently, without any iota of doubt, say the NIIA is second to none in the whole of Africa. And within the context of the efforts being made by the Minister of Foreign Affairs, Odein Ajumogobia, to evolve an enduring foreign policy for Nigeria, the NIIA has drawn a new roadmap. It is now operating on the basis of a new mantra: "New Vision, New Spirit, New Spirit, New NIIA". It is essentially predicated on making the NIIA greater than what it has been.

The NIIA is therefore poised to become a leading school of thought on international questions that have direct implications for Nigerian and African foreign policies. Emphasis will be more on explication of global strategic calculations, monitoring of international issues and conflicts within the context of preventive diplomacy, and more significantly, the dynamics of, and threat to, non-traditional security in Nigeria.

It is in this context that I have much pleasure to present the January-April 2011 edition of the niianews to you. The edition covers the visits of the Chinese delegation and students of international relations, social news and recent publications by the Institute and its staff, among others.

Comments and letters to the Editor are welcomed. Suggestions on how to drive Nigeria's foreign policy are most welcome. Registered members of the NIIA are invited to be more involved in the activities of the Institute.

### Special Brainstorming Session

- 2. Owing to Africa's experience in the slave trade, colonialism and imperialism, the continent has virtually lost its self-confidence, and that its shared values have been hijacked and imposed from the European and Arab perspectives.
- 3. There has been a serious neglect of Africa's traditional values that are natural, including shared rivers, ethnic groups, languages and religions.
- 4. Much of the AU's shared values are merely aspirational, with little or no effort being made to embody them in the consciousness of the African society and peoples.
- 5. The poor implementation of shared values in Africa has been as a result of the reluctance of member states to cede enough powers to the AU as an apex continental body.

#### On Côte d'Ivoire

- The crisis in Côte d'Ivoire is primarily an internal or domestic affair of the people, which demands that they have the primary responsibility to resolve it themselves.
- 7. Although the late *Houphouet-Boigny* was a strong leader that held the country together, he was unable to build strong institutions.
- 8. In the light of the remote cause (that is, Henri Konan Bédié's policy of Ivoirité that caused the nationality crisis) and immediate cause (that is, the disputed election) of the crisis in Côte d'Ivoire, the conflict is a complex one that requires great caution and statesmanship.
- The cause of Côte d'Ivoire crisis can also be located in the conflicting personalities of Laurent Gbagbo and Alassane Ouattara.

10. The fact that  $C\hat{o}$ te d'Ivoire is a matrilineal society has substantially resolved the nationality question in the crisis.

#### On the Sudanese Question

- 11. That colonial policies cannot be exonerated from the crisis in Sudan because the British had ruled southern Sudan separately from northern Sudan thereby creating two irreconcilable peoples.
- 12. That the Abyei region remains very problematic and tricky, and, thus, requires greater care in order to achieve a mutually acceptable solution.
- 13. And that Nigeria has a lot of nationals in Sudan even though of a third generation.

#### Recommendations:

Based on the above observations, the participants made the following recommendations:

#### On Shared Values

#### That:

- 1. The AU should go beyond its aspirational values and explore Africa's traditional and natural values such as shared rivers, ethnic groups, languages and religions.
- 2. The AU should strive to embody its aspirational values in the consciousness of the African societies and peoples.
- 3. The AU should develop strong institutional frameworks for the implementation of Africa's shared values.

To this effect, there is need to involve the civil society, explore the option of an African Youth Service Corps, and the use of international infrastructures like rail networks and high ways.

4. African shared values should be used to harness the continent's shared natural resources.

#### On Côte d'Ivoire

#### That:

- 5. In the light of the complex remote and immediate causes of the conflict, efforts should be made to address the fundamental differences between the parties.
- 6. Nigeria's national interest should be paramount in deciding what role it willplay in the resolution of the conflict.
- 7. For the sake of Nigeria's economy and the safety of its citizens in Côte d'Ivoire, Nigeria should embrace dialogue, using local Ivorian community leaders and ECOWAS leaders as interlocutors.
- 8. Nigeria should endeavour to prevent the conflict from escalating into an armed conflict and military intervention.
- 9. Nigeria should adopt a multilateral approach to the resolution of the conflict, and should rely more on the UN, France and other western

powers on the ground.

10. And that if military intervention becomes unavoidable in  $C\hat{o}$ te d'Ivoire, Nigeria should not be at the fore or use the ECOMOG, but should be involved as a part of a broader international force that has the mandate or authorization of the UN Security Council.

#### On the Sudanese Question

- 11. That if South Sudan votes for independence, the wish of the people should be respected and encouraged to manage their relationship with the north.
- 12. That support for the independence of Abyei would be a recipe for chaos in Africa because any region with rich resources would seek to have its own independent nation.

#### Dialogue on Nigeria-China Relations

he Nigerian Institute of International Affairs (NIIA) and the China Institute Contemporary International Relations (CICIR) held a one-day Dialogue on Nigeria-China Relations on Monday 21 February 2011. The Dialogue was organised as part of the programme for the 4-day academic visit to Nigeria by the Chinese delegation. The Dialogue, held at the Institute's Conference Chamber, was aimed at evolving ways of strengthening the cooperation between China and through academic Nigeria interaction by the two Institutes. The dialogue was declared open by the Ag. Director General of NIIA, Professor Bola A.Akinterinwa, and had in attendance scholars from the two institutions, former ambassadors, and some staff of the NIIA. Presentations were made and key issues raised concerning the bilateral relations of the two countries were extensively discussed. The dialogue noted that Nigeria and China have come a long way and their relations have witnessed significant development over the years. Initially characterized by quite limited

contact, especially in the immediate post-independence era, the relations have become increasingly complex and more so with the strategic push from China to deepen her engagement of Nigeria.

Nigeria, like many other African countries, viewed China as simply a non-aligned developing country in the 1960s and 1970s. Diplomatic relations between the two countries were formally established in 1971. Over the years, China's dramatic growth and modernization, and the increasing search for energy, and market for her industrial goods, and her expansion needs has brought China into greater contact with Nigeria and other African states. Nigeria seeks expertise, technology, and finance to develop her own economy. With the return to democratic governance in Nigeria, Sino-Nigeria relations have received significant attention. For instance bilateral trade between Nigeria and China stood at \$7.5 billion in 2010. However, the trade balance has remained in China's favour since 1971. For instance, in 2008, Chinese exports represented 93% of the bilateral trade total in 2008. While China's exports are mostly industrial manufactures, Nigeria's export to China is mainly oil. That notwithstanding, the Chinese are participating in so many sectors in Nigeria including oil and gas, construction and contract projects, communications, power, rail transport, manufacturing and retail, and in the development of free trade zones-especially in Lagos. Some have viewed China's engagement as an alternative to the age long engagement of Nigeria and Africa by the developed countries of the West without commensurate gains in terms of socioeconomic development. The West has remained indifferent to issues of transfer of technology, ensuring market access and general economic development of Africa. Again, the question is what are the Chinese coming to do in Africa? Are they supposed to engage in retail businesses, owning shops which they cannot accept in their own country? Why is it that they come with their labour and refuse to use local labour? Nigeria's relations with China is not without challenges. For instance, goods from China are said to be of lower standard and some Chinese are involved in the importation of fake pharmaceutical drugs into the Nigerian market. There are also concerns over the increasing influx of the Chinese population and their increasing presence in the retail business in Nigeria. China also complains of problems of insecurity, political stability, and poor infrastructure.

Following intense discussion, the participants made several observations and recommendations which include:

#### Observations

- That the peaceful rise of China has necessitated her to develop partnership with Africa and other parts of the world. However, being a developing country as Africa, China believes that rather than pursue the zero-sum pattern of relationship of the West, a win-win relationship is possible with Africa;
- Though Nigeria and China are both defined as developing countries and have some commonalities, including large population, vast landmass, and common history of underdevelopment, the two countries are at different levels of development, as China is more economically and technologically developed;
- 3. That globalisation has had significant impact on the economies of both Africa and China. However, the capacities and capabilities of these countries to respond to the challenges arising from globalisation have differed;

- That, despite the opening of the Nigerian economy to the Chinese, this has not been reciprocated either in form of the transfer of technology or visibility of Nigerian investments in China;
- That the relationship between Nigeria and China has been characterised by regular official visits and less of the academic visits;
- 6. That the relationship between Nigeria and China has, in the last 40 years, witnessed significant development and increase in exchanges especially in the area of trade. However, the trade balance has largely remained in China's favour;
- That China has both short and long term economic interest in Africa. These include her desire to secure the supply of energy and raw materials, as well as foreign markets for the products from her growing industries;
- 8. That the crisis situation in Sudan has been a major concern to China because it tends to deny Sudan of the economic gains that should have been derived from the bilateral relations. However, China's presence in the

- Sudan has been misunderstood because of her principle of non-interference;
- And that given China's increasing role on the African continent, the EU and United States have viewed her with great suspicion of being a competitor and undermining the Western interests on the continent.

#### Recommendations


- That Nigeria and China must develop measures that can address the complex implications of globalization so as to maximize the gains of the economic relations of both countries for their mutual benefit.
- That given the huge population of both countries, China's experiences in the area of industrial production, which is labour intensive, and in addressing poverty, would be of benefit to Nigeria.
- That Nigeria and Africa should stress the issue of technology acquisition and promotion in their relationship with China as this is crucial if the country and continent is to achieve economic development.
- 4. Some of the ways

of deepening the relationship between the NIIA and CICIR is to increase the level of frequency of meetings, joint research of mutual interest, and the exchange of research fellows between the two institutions. The establishment of regional studies and exchange of publications would also go a long way in deepening the institutional linkages.

- 5. Just as China learned from the advanced countries of the West and her neighbours and applied the knowledge in the process of her development, Nigeria should also learn from China and apply the lessons as it suits her environment.
- The various Memoranda of Understanding (MOU) that have been signed since 1970s should be revisited and reactivated and new ones (such as between NIIA and CICIR) developed to cater for more recent challenges.
- 7. That for Nigeria-Africa relations to continue to grow as expected, China must respect the views, values and aspirations of Africans and should also be sensitive to critical issues such as human rights on the continent.
- 8. It is important that peace should be restored in Sudan, especially with the successful conduct of referendum in Southern Sudan, and China is ready to contribute to the peace process in Sudan.
- 9. That the trilateral cooperation between the EU, China and Africa may quell the suspicion of not only China's interest, but also that of Western powers on the continent and deepen cooperation among all the parties.

# Presentation of Obasanjo Chair on Integration in Africa (Professor Amadu Sesay)

n February 19, 2011, the Acting Director General of the NIIA, Professor Bola A. Akinterinwa, led a delegation of Management Staff of the Institute to former President Olusegun Obasanjo in Abeokuta to present Professor Amadu Sesay, who had been appointed to the Obasanjo Chair on Integration in Africa. The former President observed that integration in Africa was very dear to him, adding that Africa was balkanized so that the continent could be easily exploited. He charged Professor Sesay to examine integration within the context of a nationstate such as Nigeria where issues like security, unemployment, the economy, corruption, infrastructural development and religious differences that challenge us as a country should be critically xrayed.

Professor Akinterinwa, in his own speech, described General Obasanjo as an African statesman and a global player with numerous accomplishments, especially in the area of foreign policy. These accomplishments, he said, necessitated the endowment of the Obasanjo Chair on Integration in Africa which is domiciled at the NIIA because of its strategic importance as one of the foremost Think-Tanks in Africa.

In his remarks, Professor Amadu Sesay said he had the energy, zeal, the expertise, the focus and the determination to firmly establish the Chair and confer on it national and international visibility. Amadu Sesay, a Professor of International Relations at the Obafemi Awolowo University, Ile-Ife, Nigeria, headed the Department from July 2000 to August 2006. His research interests include African politics, security and conflict studies and he has authored several books, monographs, book chapters and journal articles in these





in attendance inauguration of the Council were the Honourable Ministers of State for Foreign Affairs I and II, Dr. Aliyu Idi Hong and Mrs Salamatu Hussaini Suleiman, some senior staff of the Ministry of Foreign Affairs, management staff of the NIIA and members of the media.

In his address, the Honourable Minister of Foreign Affairs. congratulated the Council members on their appointment and commended them for their varied experiences which he said they should bring to bear on their assignment. He also extended the President's good wishes and remarked that the composition of the Council was approved in 2009, but was not inaugurated due to some inadequacies which had been addressed to make the Council function better. He also stressed that the inauguration of the Council was given timely. the current developments in world affairs, such as the referendum in Sudan with its attendant implications for Africa, the momentous events in Tunisia and Egypt, and the ongoing uprisings in Libya, Yemen, Bahrain, Iran and the crisis in Côte d'Ivoire. The NIIA, he pointed out, has played very dynamic roles during the liberation struggles for black majority rule in South Africa. He noted that, given the current challenges, the NIIA as a Think-Tank needed to be proactive.

#### **NIIA Council Holds First** Meeting

Dialogue on Nigeria-China Relations was held on Monday 21 February 2011. ## Visit of the Consul General of the United States of America to the Nigerian Institute of International Affairs

On March 31st, the Consul General of the United States of America, Mr. Joseph Stafford, visited the Institute and had an interactive session with the Research Fellows. He was received by the Acting Director General of NIIA, Professor Bola A. Akinterinwa, who briefed him on the activities of the Institute. The Ag. DG also discussed how Nigerians are mistreated when applying for US Visa and how to deepen Nigeria-US ties through facilitation of exchange of research fellows. He underscored the need to enable NIIA research fellows to specialize on American politics.

The Consul General used the opportunity of his visit to discuss the bilateral relations between Nigeria and the United States of America, noting

that the Bi-National Commission established with Nigeria has four support groups- democracy and governance; Niger-Delta; energy and economic development, and agriculture and food security. He also discussed the US intervention in Libya and said that President Barack Obama had explained that the intervention was aimed at protecting the people from the tyrannical rule of President Muammar Gaddafi. On the issue of visa procedures, he promised to bring an expert from the consulate to clarify the issues . He concluded by saying that efforts will be made to further strengthen the partnership with the NIIA. The Ag. DRS, Prof. Bukar Bukarambe, expressed the hope that the Consul General and the U.S Consulate will always be NIIA's partner.

# The National Industrial Court of Nigeria gets Recognition by Constitution

The National Industrial Court has been recognised by the Constitution as a Superior Court of Record. This followed the assent of the Constitution of the Federal Republic of Nigeria (Third Alteration Act) of 2010 by the President, Dr Goodluck Jonathan. Following this development, the President of the National Industrial Court, Hon. Justice B.A. Adejumo, OFR, forwarded a copy of the Federal Republic of Nigeria Official Gazette No. 20, Lagos 7th March, 2011, Vol. 98 to the NIIA for record purposes.




Department mounted a one-month exhibition. This comprised books, press clippings, speeches, pictures and posters depicting the various aspects of women.




Caring for the Institute's Environment- Members of staff observe the Monthly Sanitation Exercise Every Last Thursday of the Month


